It has been a busy but rewarding year, and I feel proud to be part of this well-oiled machine that is Lifeline South Coast. So many things have changed over the past pandemic years, but our teams have adjusted and continued to deliver services to people in need of a helping hand.

The challenges of lockdowns, working from home, loneliness and isolation, and grief and loss, have contributed to a decline in mental health and an increase in serious issues like family violence and financial stress. The demand for our services has increased substantially, and Lifeline South Coast continues to be a consistent presence in support of this increased demand.

Our 13 11 14 call levels reached a new record high of over 31,000 responded to by our telephone crisis support team. Along side this the team onboarded and trained up three additional cohorts of Crisis Support students to meet the current call demands and prepare for the year ahead. We are thankful to our all our volunteers from Wollongong to Nowra for their mammoth effort this year.

Message from the CEO

Year on year, Lifeline South Coast has grown our services and operations to be able to support and build individuals and communities in times of crisis and distress. 2021/22 has seen us grow again—providing more crisis support and suicide prevention services across our region through 13 11 14, the newly established 13 YARN, financial counselling, training, and community engagement. This has been possible through the financial contribution of our shops, Big Book Fair, and community fundraising support, as well as important financial contributions from local organisations and government departments.

Our mission is to empower and support our communities to be suicide-safe through connection, compassion, and hope. The year saw over 350 volunteers contribute their time and knowledge to support our activities. I am inspired and motivated in my role by the ongoing commitment of our volunteers and staff, in all the different ways they contribute to our mission.

Particular highlights for 2021/22 include the:

- Launch of 13 YARN, a 24/7 crisis support and suicide prevention service providing culturally safe and appropriate services for and by Aboriginal and Torres Strait Islander peoples
- Successful relocation of our Wollongong Shop after 30+ years at Auburn St, and the successful relocation of our book sorting team.

Looking to the new year we are committed to continuing our crisis support and suicide prevention services and excited about the opportunities that expanding our retail operations and growing our Community Ambassador program will create.

Treasurer's Report

The 2022 financial year was again impacted by Covid-19 and lockdown restrictions. While this posed a challenge, Lifeline South Coast was able to provide record support to the region, and in response our South Coast community responded by showing their support in return.

Sadly, the retail shops at Corrimal, Wollongong and Nowra were required to close during the Covid-19 lockdown. We are fortunate that our volunteers have returned, and the shops were re-opened as soon as possible.

Our Big Book Fair was cancelled in October 2021, however the overwhelming community support for the March 2022 Big Book Fair made it the most successful Lifeline South Coast history.

The annual deficit is \$388,876 as expected.

The decision was made by the Board to reinvest previous years surpluses back into supporting the community around suicide prevention help seeking, training and financial counselling.

In conclusion I would like to thank all the staff at Lifeline South Coast as well as all of our community partners who enable us to achieve what we do.
